
Lee County Clerk of Court have listed on their docket (see attached) information that is confusing to the prose appellant as compared to the order of this court and the orders of the Florida Supreme Court.

1. the respondent filed his notice of email designation as required by the Florida Supreme Court & Florida Rules of Judicial Administration on July 24, 2015. The opposing counsel did not file their email designation until August 4th, 2015 thereby missing important documents associated with the case. The Lee County Clerk refused access to the e-portal for the efficient and timely filing and service of court documents in total for this case. Prose appellant seeks clarifications of the directions of this court regarding Florida Supreme Court mandated use and Florida Rules of Judicial Administration

- of the e-portal access of the parties in this case for valid certificate of service via the e-portal.
2. The appellant is active and current in the e-portal system. The appellant has located opposing counsel and placed her within the e-portal system associated with this 2nd DCA case. Although she has yet to appear her email is registered and recognized and listed as same with the Florida Bar. Appellant requests this court to clarify that certificate of service pursuant to the Florida Supreme Court directives will be effective upon the uploading to the e-portal.
 3. The attached printout of the Lee County Docket shows that the appellant properly prepared the affidavit of indigency with the lower court and the lower court indicates a copy was provided to the 2nd DCA. The 2nd DCA indicated in a ORDER OF THE COURT that appellant must pay or submit the indigency filing. The Lee County Clerk snapshot states another order entered August 7, 2015 filing fee now required. The prose appellant requests of this 2nd district court of appeals court to clarify the various incongruities of the record between the lower and the 2 DCA and direct the appellant further responsibility in this matter of transferring documents between the two courts efficiently without redundancy to assure the full record is available.

4. The order of the 2DCA issued August 5, 2015 requires the appellant to redo the notice of appeal and submit it within 15 days or by August 20, 2015. The lower court has listed another order of the 2DCA on October 7, 2015 that shows appellant is to amend the notice of appeal prepare and submit it in 5 days. It is the appellants request that the 2DCA clarifies these incongruities between the record of the lower and the record of the 2DCA and instruct the pro-se appellant what is required of him between the lower and the 2DCA differing directions.
5. Will the amended notice of appeal, filed with the lower court, under 2.516 toll the times associated with filings? Please clarify if the order amending the notice of appeal will start a new filing date when the Amended Notice of Appeal is filed for all time requirements regarding subsequent filings.
